CALL FOR IPHC REGULATORY PROPOSALS FOR THE 2018-19 PROCESS

The International Pacific Halibut Commission (IPHC) previously published the following dates and information for use when developing and submitting proposals for new, or amending existing, IPHC Pacific Halibut Fishery Regulations for the 2018-19 process.

IPHC INTERIM MEETING: The Regulatory Proposal deadline for IM094 is **28 October 2018**.

IPHC ANNUAL MEETING: The Regulatory Proposal deadline for AM095 is **29 December 2018**.

Please note that the IPHC Fishery Regulations portal is now available for use from the IPHC website. The portal details the submission process and timelines for submission.
